Draft 2021-2025 Financial Plan – Operating Budget 3.1 Report: Finance and Technology Department – Financial Services Division, dated January 4, 2021

Staff gave a presentation on the 2021-2025 Financial Plan Draft Operating budget, including information regarding the purpose of the Financial Plan; budget timelines, process, and principles; budget challenges; historical budget increases; 2020 budget reductions due to COVID-19; budget preparation and guidelines; and the 2021 draft operating budget, including service costs, new funding requirements and requests, impacts of COVID-19, budgeted growth, tax base, average and estimated tax impacts, and next steps.

Staff answered questions from Council regarding the reclassification of the Mill and Timber property and the impacts of Bill 42, low growth versus low value of properties, asset levy reductions, vehicle charge-outs, projected revenues from recreational programs, staff layoffs, funding for new positions, distribution of the tax base and impacts on the residential class, and budget adjustments due to the impacts of COVID-19.

Darin Wong, Community and Indigenous Relations Manager, FortisBC, gave a presentation on Rethinking BC's Lower Carbon Future, including information on the Clean Growth Pathway, the province's CleanBC initiative, ten-year targets to reduce customers' greenhouse gas emissions, four pillars of the Clean Growth Pathway, and energy pathways to achieve the targeted reductions.

Report: Community Development Department – Development Planning Division, dated December 14, 2020

Staff introduced the pre-application and noted that it is similar to other PC Urban projects in the area and that the design, except for the two extra storeys, aligns with the Official Community Plan.

The applicant introduced their proposal and gave a presentation on project statistics, including site area, floor area, building height, structure, housing type, unit breakdown, transportation amenities for vehicles and bicycles, neighbourhood context, site plan, proposed benefits, transit-oriented development practices, parking plans, typical unit plans, site challenges, land locking and daylighting concerns, and building form and character.

The applicant answered questions from Council regarding the proposed Environmentally Sensitive Areas Management Strategy and its impact, the current status of other PC Urban projects, parking, unit type variations, affordable unit components, footprint, drop-off and pick-up areas, massing, and rental fees.

Councillors Lahti and Royer left the meeting at this point and did not return.
