Subject: Pedestrian Traffic Signal at St. Johns Street and Elgin Street

Purpose

To provide Council with information regarding a resolution passed by the Transportation Committee to consider, including a pedestrian traffic signal at St. Johns Street and Elgin Street.

Recommended Resolution

THAT the report dated February 2, 2021 from the Transportation Committee regarding Pedestrian Traffic Signal at St. Johns Street and Elgin Street be received for information.

Background

At the January 20, 2021 Transportation Committee meeting, staff requested that the Committee provide input on whether Council should consider a potential traffic signal at St. Johns Street and Elgin Street. After discussion, the Committee passed the following resolution:

TC21/004

THAT the Transportation Committee support the consideration of a pedestrian traffic signal at St. Johns Street and Elgin Street for inclusion in the Master Transportation Plan Implementation Plan.

Discussion

Staff noted at the meeting that the Engineering Division had received requests for a traffic signal at St. Johns Street and Elgin Street, which is currently not included on the Master Transportation Plan (MTP) Implementation Plan. Staff noted that there is currently no specific funding for the signals proposed in the MTP in the coming year, as funding has been prioritized for work on St. Johns Street and other near-term MTP projects. However, new signals will be considered based on funds and off-site construction commitments by nearby development projects and as MTP implementation continues into future years (subject to annual capital plan approval). The installation of new traffic signals should only be considered when traffic and environmental conditions warrant a signal consistent with national guidelines. The installation of unwarranted signals can cause unnecessary delays, issues with compliance, and potential safety concerns. Staff also noted that TransLink approval for new traffic signals on Major Road Network (MRN) roads depends on its impact to people moving capacity.

The Committee discussed the item, with some members suggesting that additional traffic signals may be better suited along longer City blocks, such as on St. Johns Street between Williams Street and Buller Street. The Committee noted that additional traffic signals along St. Johns Street can improve pedestrian safety and walkability, and that including the traffic signal at Elgin Street in the MTP can potentially help to leverage future development funding for the signal.

Other Options

- THAT the report dated February 2, 2021 from the Transportation Committee regarding Pedestrian Traffic Signal at St. Johns Street and Elgin Street be referred to staff for information.
- THAT the report dated February 2, 2021 from the Transportation Committee regarding Pedestrian Traffic Signal at St. Johns Street and Elgin Street be referred to staff for action.
