Subject: 2021 Work Plan – Heritage Commission

Purpose

To seek Council approval for the 2021 Heritage Commission Work Plan.

Recommended Resolution

Background

Per the Council Committee System Policy, committee terms begin in January and end in December. Committees are required to submit an annual Work Plan in the spring for Council approval.

Discussion

The 2021 Financial Plan includes an allocation of \$10,000 for the Heritage Commission's Work Plan and budget in 2021. Some 2021 Work Plan items may require additional funding. The Heritage Commission will submit a report to Council at the appropriate time for projects requiring additional funding and will recommend a budget and funding source at that time.

No communications or civic engagement initiatives are required with the approval of the work plan. Should any communications and civic engagement initiatives be required as part of a work plan item, the Heritage Commission will submit a report to Council at the appropriate time.

- bring people together by activating public spaces.
