| To request support from Port Moody City Council for Inlet Rowing Club's proposal to house the BC NexGen Performance Center.  |
| Details of Request:  |
| Inlet Rowing Club, located at the Old Mill Boathouse at Rocky Point Park, is putting together a formal proposal to Rowing BC and Rowing Canada to bid on being the new home for the BC NextGen Performance Center. This center will provide a training environment for NextGen athletes – rowers who are typically 5-8 years away from a potential Olympic or ParaOlympic Podium. Rowing BC is seeking a permanent home for the Center starting September 2021 where NextGen athletes in BC can train full time.   |
| We believe Inlet Rowing Club would be the ideal location for this center. The waters off Rocky Point Park provides one of the best long-course waterways for rowing in the lower mainland, Port Moody is very centrally located with a well-rounded set of amenities and multiple transit options, and our club, along with Old Mill Boathouse, provides the perfect setting for training.   |
