Subject: Proposed Amendments to the Sound Level Bylaw – First Three Readings

At the Regular Council meeting held on March 23, 2021, Council considered a report dated January 22, 2021 from the Community Development Department – Building, Bylaw, and Licensing Division regarding Proposed Amendments to the Sound Level Bylaw (**Attachment 1**) and passed the following resolution:

RC21/161

THAT staff be directed to amend draft City of Port Moody Sound Level Bylaw, 1980, No. 1399, Amendment Bylaw No. 7, 2021, No. 3299 to allow for construction from Monday to Friday during the hours of 7:00am to 7:00pm, and on Saturday during the hours of 9:00am to 6:00pm;

AND THAT staff be directed to amend draft City of Port Moody Fees Bylaw, 2020, No. 3278, Amendment Bylaw No. 2, 2021, No. 3304 to increase the application fee for Exemption from Sound Level Bylaw to \$500;

AND THAT Corporate Policy – 09-3760-2021-01 – Temporary Exemption from Sound Bylaw be approved.

City of Port Moody Sound Level Bylaw, 1980, No. 1399, Amendment Bylaw No. 7, 2021, No. 3299—a Bylaw to amend City of Port Moody Sound Level Bylaw, 1980, No. 1399 to change the hours of construction—(**Attachment 2**) and City of Port Moody Fees Bylaw, 2020, No. 3278, Amendment Bylaw No. 2, 2021, No. 3304—a Bylaw to amend City of Port Moody Fees Bylaw, 2020, No. 3278 to add a fee for Application for Temporary Exemption from the Sound Level Bylaw—(**Attachment 3**) are now before Council for consideration of first, second, and third reading. The recommended resolution is:

**THAT City of Port Moody Sound Level Bylaw, 1980, No. 1399, Amendment Bylaw No. 7, 2021, No. 3299 and City of Port Moody Fees Bylaw, 2020, No. 3278, Amendment Bylaw No. 2, 2021, No. 3304 be read a first, second, and third time as recommended in the memo dated April 5, 2021 from the Legislative Services Division regarding Proposed Amendments to the Sound Level Bylaw – First Three Readings.**
