

## Summary of Spring/Summer Planning

- EOC Staffing/Financing
  - o Allocating a PT dedicated staff resource for advanced planning, documentation, and recovery activities for the EOC (starting April 2021)
  - o Submitting a budget report to request use of Recovery Grant funds for operational COVID-19 response activities
- Picnic Shelters
  - o Deferring picnic shelter bookings to avoid congregating
  - o Adding signage to encourage the public to keep visits to under 2 hours (to encourage turnover)
  - o Parks looking into whether we can move every other picnic table to other areas to allow for more spacing
- Wedding/funeral/event bookings
  - o Deferring event rentals at until After August 31, 2021
  - o Deferring all City sponsored events until after August 31, 2021
  - o Parks and Facilities looking into whether the City Hall outdoor forum could be used for wedding/funeral bookings
- Drinking/smoking in parks
  - o Increasing enforcement support in parks with new bylaw position
  - o Adding signage to reinforce no drinking/smoking in parks
  - o Reaching out to breweries for coordinated messaging
- Parks maintenance
  - o Adding portable toilets to manage washroom demand
  - o Adding staff hours to ensure frequent cleaning and garbage/recycling/litter pick-up (especially with anticipated increase in take-out waste)
- Washroom access
  - o Adding portable washroom at 1<sup>st</sup> Ave water access
  - o Adding portable washrooms at in-demand park areas
- Vandalism
  - o Installing more permanent signage to reduce vandalism
  - o Installing a security camera at Rocky Point Park with signage to deter vandalism
- Parking
  - o Installing signage to direct overflow parking to Translink site
  - o Extending parking restrictions timeframe until 11pm to encourage parking turnover
  - o Ensuring no parking closures
  - o Increasing enforcement support in parking lots with new bylaw position
- Bedwell Bay Road
  - o Adding fixed in place regulatory signs at key locations to improve enforcement
  - o Adding low concrete barriers in the temporary no-parking area near the swim floats (can be removed or re-located as required)
  - o Coordinating bylaw enforcement activities for this area
- Boat Launch
  - o Keeping annual pass system
  - o Adding permanent directional signage to indicate for boat launch use only, to show that other vehicles need to turn left into the parking lot in front of the Boathouse Restaurant

- Business Support
  - Continuing measures implemented in 2020 to support businesses. City will consider proposals from Port Moody businesses that require:
    - temporary relaxations to onsite parking requirements to allow uses such as queuing and patios;
    - consideration of closing street parking to accommodate other uses;
    - temporary use of City-owned spaces, such as parking lots and sidewalks, provided sufficient pedestrian and cycling access is maintained; and
    - use of the City's new Parklet Program
- Busking
  - Deferring busking permits (to avoid congregating situations), communicating with buskers about City's position
- Slow Zones/Traffic Control
  - Implementing Alderside Road Slow Zone
  - Continuing St. George Street Slow Zone
