 Alderside Road and Old Orchard Park – Requests for Traffic and Accessibility Improvements

#### Purpose

To provide a summary of traffic and accessibility requests received for Old Orchard Park and Alderside Road and request direction on potential actions.

## Recommended Resolution(s)

THAT the outstanding requests and concerns related to Old Orchard Park be referred to the upcoming Old Orchard Park Master Plan project as recommended in the report dated May 7, 2021 from the Engineering and Operations Department – Infrastructure Engineering Services Division regarding Alderside and Old Orchard Park – Requests for Traffic and Accessibility Improvements;

AND THAT outstanding requests and concerns related to Alderside Road be referred to a future Alderside Road Traffic Calming Initiative project to be initiated as prioritized through the City's traffic calming process.

## Background

During the COVID-19 pandemic in 2020, public demand for park and recreational facilities increased significantly. This increase in demand was exacerbated by health order restrictions and best practices that required physical distancing – effectively reducing the capacity of such facilities.

A brief summary of actions taken around Old Orchard Park and Alderside Road since the start of the COVID-19 Pandemic in 2020 is included below:

- temporarily closed a portion of the Old Orchard Hall parking lot to reduce park use;
- temporary playground closures;
- suspension/cancellation of bookings for Old Orchard Hall along with other facility closures;
- implementation of a one-way loop on the Shoreline Trail;
- physical distancing signage within the parks; and
- increased bylaw presence and introduction of park hosts at busy parks and trails.

Other COVID-19 related responses by the City and other senior government organizations such as Metro Vancouver and the Province may have also contributed to increased demand at Old Orchard Park, with a side effect of increasing traffic on Alderside Road on busy summer days. These include:

- temporary Provincial Park closures and subsequent permit access system;
- park capacity and parking lot capacity restrictions at Belcarra Regional Park, White Pine Beach, and Buntzen Lake;
- temporary parking ban along Bedwell Bay Road; and
- Rocky Point Park capacity and parking lot capacity restrictions.

The effects of these changes have been seen at many parks and informal use areas including the road end at the south end of 1<sup>st</sup> Avenue south of loco Road, where demand has increased significantly to the point where the City has needed to place a temporary washroom (portable toilet) for the 2020 and 2021 summer seasons.

On August 10, 2020, staff, Mayor and Councillors met with representatives of The Residents of Pleasantside IOCO Communities Association (TROPICA) at Old Orchard Park to discuss concerns and requests around the park and on Alderside Road. Specific requests are detailed in the Discussion section below but were generally focused on traffic and pedestrian safety and park accessibility.

Following this meeting, staff implemented several changes, including signage changes to add an accessibility parking stall on Alderside Road, improvements to some outstanding minor signage issues, and a temporary pedestrian space along Alderside Road alongside Old Orchard Hall.

The 2020 Alderside Slow Zone was removed in September once the peak summer park season ended. For 2021, the Slow Zone has been reinstated for dates between the May Long Weekend and Labour Day.

Several of the above traffic concerns were reported to the Transportation Committee on September 16, 2020, including some conceptual improvement ideas for discussion. The Committee passed the following motion:

#### TC20/025

THAT the Transportation Committee support staff reporting back with conceptual options for longer term improvements to Alderside to assist with parking, traffic, and active transportation concerns.

In addition to TROPICA requests, other concerns have continued to be received around access and traffic at Old Orchard Park and Alderside Road. This report summarizes that feedback and requests direction on next steps in studying and developing recommendations to address concerns.

## Discussion

Traffic and accessibility related concerns have been received about both Old Orchard Hall and Alderside Road over many years; however, frequency of concerns in the area has increased in 2020 and 2021 during the COVID-19 pandemic and with increased outdoor recreational activity and park use.

Concerns have been received through meetings with TROPICA (August 10, 2020 at Old Orchard Park, January 25, 2021 at Alderside Slip Road), and by emails and phone calls from Alderside Road and nearby residents. Recent feedback is summarized generally below by location, along with implemented or recommended actions.

Alderside Road/General Traffic Concerns:

Generally, concerns have centred around traffic and parking issues related to increased park and outdoor recreational use (cycling, walking, running, etc.) in the area and demand for improved accessibility for pedestrians and park users. As noted above, many of the concerns have been addressed on an interim basis or permanently. The remaining issues require further planning, coordination, budgeting, and, in many cases, studies to confirm the best approach to addressing the issues.

An Old Orchard Park Master Plan project is included in the City's approved 2021 Capital Plan. It is recommended that the outstanding Old Orchard Park-related issues be referred to this project for consideration.

Alderside Road underwent a traffic calming initiative under the City's *Neighbourhood Traffic Calming Policy (11-5460-02)* in 2006, but the final recommendation (two speed humps) did not receive sufficient neighbourhood support (2/3 of survey respondents) for installation under the policy. Since that time, local perceptions on traffic safety, active transportation, and street use priorities have changed. As traffic concerns continue to be received on Alderside Road, and as the road provides a key pedestrian and cycling connection for the loco/Pleasantside neighbourhoods, Alderside Road has been included on the City's Traffic Calming Initiative Candidates list (**Attachment 1**).

Per the City's current approach to traffic calming, approved by Council on February 9, 2021, these traffic calming initiatives are to be completed at a rate of about one per year (based on currently available resources) as prioritized by the Transportation Committee considering preliminary screening criteria outlined in the City's *Neighbourhood Traffic Calming Policy*. When the Alderside Road traffic road traffic calming initiative proceeds in the future, it is recommended that the items in the related items in the table above be considered as part of the traffic calming study.

## Other Option(s)

THAT the report dated May 7, 2021 from the Engineering and Operations Department – Infrastructure Engineering Services Division regarding Alderside and Old Orchard Park – Requests for Traffic and Accessibility Improvements be received for information.

## **Financial Implications**

The Old Orchard Park Master Plan is included in the approved 2021 Capital Plan with a budget of \$86,300. Approval of a budget for an Alderside Road Traffic Calming Initiative will be requested as part of future capital plans as priorities and timelines are confirmed.

It is anticipated that both of the above projects will identify future improvement projects which will require allocation of budget and staff resources for implementation.

## **Communications and Civic Engagement Initiatives**

This report serves to summarize feedback received from area residents. As the referenced projects are initiated, communication plans will be developed to suit.

# **Council Strategic Plan Objectives**

This initiative aligns with Council's 2019-2022 Strategic Priorities of Exceptional Service, Healthy City, and Community Evolution. Council identified the Old Orchard Park Master Plan project as a Priority 2 Strategic Plan Project.
