Purpose

To seek Council approval for the revised 2021 Arts and Culture Committee Work Plan.

Recommended Resolution

THAT the revised 2021 Arts and Culture Committee Work Plan be approved as recommended in the report dated June 14, 2021 from the Arts and Culture Committee regarding Revised 2021 Work Plan – Arts and Culture Committee.

Background

The 2021 Arts and Culture Committee Work Plan was approved by Council at the Regular Council meeting held on February 23, 2021. As the COVID-19 pandemic continues through the summer of 2021, the Committee feels that the work items should be revised to focus on opportunities to enhance arts and culture and build on the potential to create and market an arts festival event in 2022.

Discussion

At the June 7, 2021 Arts and Culture Committee meeting, the Arts Festival Subcommittee provided an update on planning for an arts festival in 2022. A film competition was proposed to create an online presence in 2021, which would also serve to promote the 2022 festival. The Committee passed the following resolution:

ACC21/013

THAT, in order to provide the Outdoor Arts Festival with an online presence, a film competition about Port Moody be added to the 2021 Arts and Culture Committee Work Plan.

The draft revised 2021 Arts and Culture Committee Work Plan is included as Attachment 1.

Other Option

THAT the revised 2021 Arts and Culture Committee Work Plan contained in the report dated June 14, 2021 from the Arts and Culture Committee regarding the Revised 2021 Work Plan – Arts and Culture Committee be amended as directed by Council.

Financial Implications

Some 2021 Work Plan items may require funding. The Arts and Culture Committee will submit a report to Council at the appropriate time for projects requiring funding and will recommend a budget and funding source at that time.

No communications or civic engagement initiatives are required with the approval of the Work Plan. Should any communications and civic engagement initiatives be required as part of a Work Plan item, the Arts and Culture Committee will submit a report to Council at the appropriate time.
