Subject: 2020 Annual Water Quality Report

Purpose

To present the City's 2020 Annual Water Quality Report for Council's information.

Recommended Resolution(s)

THAT the report dated July 6, 2021 from the Engineering and Operations Department – Operations Division regarding 2020 Annual Water Quality Report be received for information.

Background

The British Columbia Drinking Water Protection Act and the British Columbia Drinking Water Protection Regulation require the City of Port Moody to conduct monitoring of the City's water distribution system and publish the results in an annual report. The 2020 Annual Water Quality Report (**Attachment 1**) fulfills this requirement by outlining all water quality sampling results, and confirms that the City has maintained its water distribution system in a manner that meets all applicable laws and standards.

Discussion

Metro Vancouver collects and analyzes water samples from the distribution system on behalf of the City of Port Moody. A full summary of all water quality sampling results can be found in the appendices of the 2020 Annual Water Quality Report.

A summary of the water distribution system operation and maintenance activities undertaken in 2020 is presented in **Attachment 2**.

This report has been submitted to Fraser Health Authority, and will be made available to the public in accordance with the British Columbia Drinking Water Protection Act and British Columbia Drinking Water Protection Regulation.
