Subject: Amendment to Schedule B of the Sound Level Bylaw

Purpose

To present City of Port Moody Sound Level Bylaw, 1980, No. 1399, Amendment Bylaw No. 8, 2021, No. 3322 for Council consideration.

Recommended Resolution(s)

THAT City of Port Moody Sound Level Bylaw, 1980, No. 1399, Amendment Bylaw No. 8, 2021, No. 3322 be read a first, second, and third time as recommended in the report dated September 7, 2021 from the Community Development Department – Building, Bylaw, and Licensing Division regarding Amendment to Schedule B of the Sound Level Bylaw.

Background

Council amended the Sound Level Bylaw No. 1399, hours of construction on April 27, 2021, with Amending Bylaw 2021, No. 3299. Inadvertently, Schedule 'B,' section 5, which directly references hours of construction, was not amended; therefore, Schedule B is no longer accurate or consistent with other section of the Bylaw.

Discussion

A new Amending Bylaw (**Attachment 1**) has been prepared to amend Schedule 'B,' section 5 of the Sound Level Bylaw No. 1399 to reflect the current permitted hours of construction.

Other Option(s)

Adoption of the amendment bylaw is required for legislative compliance; therefore, no other options are being presented.

Bylaw No. 3322

A Bylaw to amend City of Port Moody Sound Level Bylaw, 1980, No. 1399 to change the hours of construction in Schedule B.

The Council of the City of Port Moody enacts as follows:

1. Citation

- 1.1 This Bylaw may be cited as "City of Port Moody Sound Level Bylaw, 1980, No. 1399, Amendment Bylaw No. 8, 2021, No. 3322".

2. Amendments

- 2.1 City of Port Moody Sound Level Bylaw, 1980, No. 1399 is amended by replacing the following Schedule B section 5:

"In accordance with section 4.2 of this Bylaw, the sound made by construction activity prior to 7:00 a.m. and after 8:00 p.m. on Monday to Saturday inclusive or prior to 9:00 a.m. and after 6:00 p.m. on Sundays and Statutory Holidays."

with the following Schedule B section 5:

"In accordance with section 4.2 of this Bylaw, the sound made by construction activity prior to 7:00am and after 7:00pm on Monday to Friday and prior to 9:00am and after 5:00pm on Saturday inclusive, or prior to 9:00am and after 6:00pm on Sundays and Statutory Holidays."

3. Severability

- 3.1 If a portion of this Bylaw is found invalid by a court, it will be severed and the remainder of the Bylaw will remain in effect.
