Call to Order

Mayor Vagramov called the meeting to order at 8:16pm.

Art at Council

1.1 Verbal Report: Councillor Zoë Royer, Chair, Arts and Culture Committee

Councillor Royer introduced the evening's Art at Council, three vinyl wraps designed by Sara Graham in collaboration with the Parks Department. Sara Graham was the City's Resident Staff Artist until July 2021. Councillor Royer noted that the wraps were designed to integrate with the surrounding vegetation and that most of the shapes in the designs were inspired by the trees and plants in the area. Councillor Royer advised that the *Wild as the Wind* wrap is located on Murray Street at the entrance to the Rocky Point Park parking lot; *The Quiet of Night* wrap is located on Murray Street at the southwest corner of the Rocky Point Park parking lot; and the *In the Open Air* wrap is scheduled to be installed before the end of the year.

2. Public Input

Judy Taylor-Atkinson (Port Moody) expressed concerns about the application presented at the November 8, 2021 Land Use Committee meeting, noting that she is concerned about the arborist consultant's business practices. Ms. Taylor-Atkinson suggested that a different arborist be consulted to confirm the original report findings and investigate opportunities to retain more trees on the site.

Hazel Mason (Port Moody) expressed concerns about how her comments at the October 26, 2021 Regular Council meeting were characterized and requested an amendment to the minutes.

Jeff McLellan (Port Moody) expressed support for the Heritage Designation Bylaw, and thanked Fred Soofi for his heritage conservation efforts in the city. Mr. McLellan expressed concerns about the mental health and well-being of Port Moody's youth and requested that Council support youth events and programming as much as possible to ensure these important services are available in the community. Mr. McLellan noted that the Crossroads Hospice Society's *I'll Be Home for Christmas...Again? Virtual Gala* is scheduled for Saturday, November 20, 2021, and encouraged everyone to support this important community partner.

Jonathan Leighs (Port Moody) expressed concerns about the Coronation Park neighbourhood OCP amendment application, noting that the current location map does not include properties west of Balmoral Drive. Mr. Leighs requested that the location map boundary be revised to include these properties for consideration in the OCP amendment and maximize the opportunity to create a vibrant transit-oriented neighbourhood.

Julie Lebrun (Port Moody), Minster at Inlet United Church, expressed concerns about the proposed 2022 Fees Bylaw, noting that the Church is building new affordable housing units in Port Moody and that keeping water and sewer rates low would support the long-term sustainability of lower rents. Ms. Lebrun requested that a not-for-profit housing category for water and sewer rates be created to support affordable housing in the city.

Delegation – Port Moody Rotary – RibFest 3.1 Presentation: Frank Marchand (RibFest Co-Chair) and Alan Schmelzel (RibFest Logistics)Delegation Request: Frank Marchand

Frank Marchand, RibFest Co-Chair, and Alan Schmelzel, RibFest Logistics, gave a presentation on how the Rotary Club has continued to serve the community throughout the pandemic, and on their plans for RibFest 2022. The delegation requested that the RibFest funding commitment for 2019-2021 be extended to 2023 due to the cancellation of the 2020 and 2021 events because of the COVID-19 pandemic.

The delegation answered questions from Council regarding time constraints.
