Subject: Fines for Parking Within 5m of a Fire Hydrant – Adoption

At the Regular Council meeting held on November 23, 2021, Council considered a report dated November 5, 2021 from the Community Development Department – Building, Bylaw, and Licensing Division regarding Fines for Parking Within 5m of a Fire Hydrant (**Attachment 1**) and passed the following resolution:

RC21/480-483

THAT City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 5, 2021, No. 3334 be read a first, second, and third time as recommended in the report dated November 5, 2021 from Community Development Department – Building, Bylaw, and Licensing Division regarding Fines for Parking Within 5m of a Fire Hydrant, with the amendment of the fines to \$500 for the full penalty and \$300 for the discounted penalty.

City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 5, 2021, No. 3334—a Bylaw to amend City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218 to increase the fine for parking within five metres of a fire hydrant—(**Attachment 2**) will be before Council for consideration of adoption at the Special Council (Committee of the Whole) meeting of December 7, 2021.
