Dianna Brown and Laura Dick provided an overview of the draft uutility box wraps for Marcon and requested Commission members' feedback, and the following was noted:

- Johnston Residence Storyboard to include the date that the home was added to the Port Moody Heritage Registry, the image of typical Foursquare style home to be cleaned-up and may potentially be utilized on the site;
- it may be necessary to seek potential third-party funding for the Johnston Residence Storyboard;
- image resolutions may require adjustments based on the size of the boxes;
- high voltage box warning labels will be placed on top of the wrap;
- the historical images reflect the evolution of the site and will provide an opportunity for residents to connect to the history of the area; future opportunities for wraps could consider highlighting different types of heritage; and
- wording for storyboards should be edited, and further research should be conducted to confirm and/or enrich the existing information.
