Culverting Policy – A Roundtable Discussion	4.1	Attachment: Report, Environmental Services Department, dated December 1, 1997
		The Committee undertook a roundtable discussion about the Culverting Policy Report, and the following was noted:
		 the previous Culverting Policy recommended to Council by the Environmental Protection Committee in 1997 involved the formation of a subcommittee and discussion at several Committee meetings; the referral of the Culverting Policy from Council will impact progress on other items in the work plan; there is some inconsistent information on the classification of ditches in the City's documentation, including the Chines Integrated Stormwater Management Plan, the Official Community Plan, Diamondhead Consulting Environmentally Sensitive Areas (ESA) report, and Port Moody zoning bylaws; compensation for homeowners for implementation of green infrastructure is needed to address the financial burden to homeowners for infilling a ditch or watercourse; and ditches have become important features for preventing flooding and management stormwater due to the impacts of climate change.
		The Environmental Coordinator noted the following in response to the Committee's discussion:
		 there are differences between a ditch and a channelized stream; permits/notifications are required when there are works within a stream that meets the definition of a watercourse under the <i>Water Sustainability Act</i>; the Moody Centre Stormwater Servicing Plan was developed in consultation with staff and KWL Associates; the strategy identified policy gaps in stormwater management around Moody Centre, including ditches; the Plan and supporting recommendations were endorsed by Council in 2019; some actions are within staff's existing work plan, such as the establishment of a ditch enclosure permitting process, where appropriate and following senior

environmental regulations, and amendments to the zoning bylaw; and

- there are provincial regulatory requirements for watercourses; and
- the applicability of the provincial/federal regulations depends on watercourse classification and definitions in the Water Sustainability Act, Riparian Areas Protection Regulation, and Fisheries Act.

Javney Mohr left the meeting at this point.

Moved, seconded, and DEFEATED **THAT the Culverting Policy be referred back to Council.** (Voting against: Margaret Birch, Kyle Demes, Jutta Rickers-Haunerland, and Koy Tayler)

Moved, seconded, and CARRIED THAT an update about information on ditches, culverts, and jurisdiction be provided to Council;

AND THAT the presentation on the progress on the recommendations on the Moody Centre Stormwater Management Servicing Plan be forwarded to Council for information;

AND THAT education about the benefits of different watercourse and ditch options be provided to the public;

AND THAT provincial support for homeowners in order to implement green infrastructure projects for compensation in the City of Port Moody be explored.

The Committee requested information on the costs of the ESA Management Strategy update including staff time billed to the project.

- the project is currently undergoing a legal review.
