On February 22, 2022, Council gave first and second readings of City of Port Moody Land Use Contract Termination Bylaw, 2022, No. 3337 (San Remo Drive) and City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 66, 2021, No. 3338 (San Remo Drive) (CD88) and referred these bylaws to Public Hearing.

Staff have since identified an additional Land Title and Survey Authority (LTSA) charge for a 2006 amendment to the San Remo Drive land use contract which affects several properties. An update to Bylaw No. 3337 is required to release this charge from the affected properties. To move forward with an updated bylaw, it is requested that first and second readings of Bylaw 3337 and its referral to Public Hearing given on February 22, 2022 be rescinded and that the updated version of Bylaw 3337 included in **Attachment 1** proceed as recommended below.

AND THAT Bylaw No. 3337 be referred to a Public Hearing.
