 an inclusive approach to heritage will be a focus in 2022, practices of other municipalities could be reviewed, and

- a roadmap could be created;
- a subcommittee could be formed to work on creating this inclusive approach and roadmap, and give an update on its progress to the Commission mid-2022;
- the Heritage Register could be reviewed, and suitable properties for addition to the Register could be identified; and
- a comprehensive review, including the nomination and awarding criteria, could be undertaken for the Heritage Award.

The Policy Planner gave a presentation on the Heritage Strategic Plan Review, noting that the current Heritage Strategic Plan is expiring in 2022 and that as one of the main stakeholders, the Commission will have an opportunity to provide input for the new plan.

The Chair noted the following:

- the current Heritage Strategic Plan is comprehensive about some aspects of colonial heritage, and there is a lack of information on other types of heritage;
- the vision statement needs to be revisited; and

The Commission noted the following in discussion:

- heritage is narrowly defined in the current Heritage Strategic Plan, and broadening the definition of heritage value is necessary;
- a more inclusive language should be used in the new Heritage Strategic Plan; and
- other municipalities' Heritage Strategic Plans could be reviewed to help guide the process.
