Call to Order

Mayor Vagramov called the meeting to order at 7:07pm.

Art at Council

1.1 Verbal Report: Councillor Zoë Royer, Chair, Arts and Culture Committee

Councillor Dilworth introduced the evening's Art at Council, a series of clay artworks titled *Moonbeam* by local ceramic artist Ysabella Choung. Councillor Dilworth noted that Ms. Choung's work is distinguished by its modern and curved lines, playful movement, and naturalistic tension, and that she specializes in unique handmade functional pieces for daily use, as well as in hand-cut paper collage and illustrations in abstract, organic forms, arranged in colour combinations. Councillor Dilworth also noted that Ms. Choung is the owner of Spatial Art + Design Studio in Port Moody and works as the Ceramic Studio Manager and Technician at PoMoArts. Councillor Dilworth invited Ms. Choung to speak about her art.

Ms. Choung noted that she created *Moonbeam* during the pandemic and used her passion for art to help shift her perspective and find hope for the future. Ms. Choung also noted that she enjoys teaching people how to create art and hopes that her work moves the audience and transports them to a place of hope and peace. Ms. Choung advised that her work will be displayed in the *Re: Through the Times* exhibition at PoMoArts and invited everyone to attend the exhibition reception on Thursday, April 14, 2022 at 6:00pm.

2. Public Input

Kyla Knowles (Port Moody) expressed support for the recent provincial legislative amendments that will offer local governments new tools for when elected officials are charged with or convicted of a criminal offence, noting that the legislation will help hold elected officials accountable and ensure the wellbeing of the communities they represent.

Richard Biedka (Port Moody) expressed concerns about the 2022 tax rates, noting that many residents are still struggling from the effects of the pandemic and the rising cost of living, and suggested that the proposed tax rate be reduced.
