Purpose

To provide Council with information regarding a resolution passed by the Arts and Culture Committee regarding Artist Payment Guidelines.

Recommended Resolution

THAT the report dated April 5, 2022 from the Arts and Culture Committee regarding Artist Payment Guidelines be received for information.

Background

The creation of Fair Compensation for Artists Guidelines has been an item on the 2020, 2021, and 2022 Arts and Culture Committee Work Plans. At the April 4, 2022 Arts and Culture Committee meeting, the Committee reviewed the final draft of the Artist Payment Guidelines for Event Organizers and passed the following resolution:

ACC22/007

THAT the Artist Payment Guidelines for Event Organizers be approved as amended and made available on the City's website.

Discussion

At the April 7, 2021 Arts and Culture Committee meeting, the Committee reviewed the City of Prince Albert's Artist Payment Guidelines for Event Organizers, and formed the Fair Compensation for Artists Subcommittee to develop a City of Port Moody fair compensation for artists guidelines document which would outline the value and considerations of compensating artists fairly.

At the July 5, 2021 Arts and Culture Committee meeting, the Fair Compensation for Artists Subcommittee presented the draft guidelines for compensating professional artists for Committee feedback. The Committee agreed that the guidelines were appropriate and the Manager of Cultural Services agreed to draft a City document based on the guidelines and present them to the Committee at a future meeting.

At the April 4, 2022 Arts and Culture Committee meeting, the Manager of Cultural Services presented the final draft of the Artist Payment Guidelines for Event Organizers (**Attachment 1**) for the Committee's approval.
