### Purpose

This report seeks Council endorsement of the Public Engagement Strategy being proposed by staff for the Rocky Point Park and Old Orchard Park Master Plans.

### Recommended Resolution(s)

**THAT the Rocky Point Park and Old Orchard Park Master Plans Public Engagement Strategy be endorsed as recommended in the report dated May 6, 2022 from the Engineering and Operations Department – Project Delivery Services Division regarding Rocky Point Park and Old Orchard Park Master Plans Public Engagement Strategy.**

### Background

The purpose of the Rocky Point Park and Old Orchard Park Master Plans is to develop a comprehensive 10-year Master Plan Update for Rocky Point Park and a Master Plan to guide moderate upgrades for Old Orchard Park. While Rocky Point Park and Old Orchard Park have different characteristics and take on different roles within the City, the Master Plans developments are conducted concurrently, in a coordinated manner, and by the same consultant team in order to provide a holistic vision for both of the parks and the waterfront parks, open spaces, trails and habitat systems.

### Discussion

The project started in March 2022 and is currently in the phase one – Background Review, Context and Site Analysis. To facilitate public and stakeholder engagement and consultation for this project, staff have prepared the attached Rocky Point Park and Old Orchard Park Master Plans Public Engagement Strategy dated May 6, 2022 for Council review and endorsement.

As outlined in the project timeline, the first round of public and stakeholder engagement will be held in Spring - Summer 2022. As such, Council endorsement of the attached strategy is now requested.

### Other Option(s)

THAT Council direct staff to report back on alternative approaches to public consultation.

\*It should be noted that reporting back on alternative approaches to consultation could result in delays to the overall project.

## Financial Implications

The anticipated costs of the proposed public engagement activities are already accounted for within the project budget and, as such, there are no additional financial implications.

If Council approves the engagement strategy, staff will work with the project consultant to implement the attached strategy.
