Subject: Zoning Bylaw Amendment and Land Use Contract - Angela Drive – Third Reading and Adoption

At the Regular Council meeting held on May 10, 2022, Council considered a report dated April 27, 2022, from the Community Development Department – Policy Planning Division regarding Termination of Land Use Contract at Angela Drive and Rezoning to RS1-S and RS1 (**Attachment 1**) and passed the following resolution:

RC22/160

THAT City of Port Moody Land Use Contract Termination Bylaw, 2022, No. 3351 (Angela Drive), City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 68, 2022, No. 3354 (Angela Drive) (RS1), and City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 69, 2022, No. 3355 (Angela Drive) (RS1-S) be read a first and second time as recommended in the report dated April 27, 2022 from the Community Development Department – Policy Planning Division regarding Termination of Land Use Contract at Angela Drive and Rezoning to RS1-S and RS1;

AND THAT Bylaw No. 3351, Bylaw No. 3354 and Bylaw No. 3355 be referred to a Public Hearing;

AND THAT the requirement to notify tenants and property owners within 140m of the perimeter boundary of the LUC area per Development Approval Procedures Bylaw, No. 2918 be waived.

City of Port Moody Land Use Contract Termination Bylaw, 2022, No. 3351 (Angela Drive) - a Bylaw to terminate the Land Use Contract for Angela Drive (**Attachment 2**), City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 68, 2022, No. 3354 (Angela Drive) (RS1-S) and City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 69, 2022, No. 3355 (Angela Drive) (RS1-S) (**Attachment 3**) – bylaws to apply RS1 and RS1-S properties previously subject to a Land Use Contract for Angela Drive are the subject of a Public Hearing to be held on June 14, 2022. If referred from the Public Hearing, Bylaws No. 3351, No. 3354 and 3355 would be before Council for consideration of third reading and adoption.

The recommended resolutions are:

THAT City of Port Moody Land Use Contract Termination Bylaw, 2022, No. 3351 (Angela Drive), City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 68, 2022, No. 3354 (Angela Drive) (RS1), and City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 69, 2022, No. 3355 (Angela Drive) (RS1-S) be now read a third time as recommended in the memo dated June 3, 2022 from the Community Development Department – Policy Planning Division

regarding Zoning Bylaw Amendment and Land Use Contract Termination – Angela Drive – Third Reading and Adoption;

AND THAT Bylaws No. 3351, No. 3354, and No. 3355 be now adopted.
