Subject: Pioneer Park Rentals

Purpose

To provide Council with information regarding a resolution passed by the Parks and Recreation Commission to investigate alterative locations to Pioneer Memorial Park for the Brewhalla Beer and Music Festival.

Recommended Resolution

THAT the report dated May 20, 2022 from the Parks and Recreation Commission regarding Pioneer Park Rentals be received for information.

Background

At the April 13, 2022 Parks and Recreation Commission (PRC) meeting, the Commission received information from the Manager of Cultural Services regarding Pioneer Park Rental Fees (**Attachment 1**). Following a discussion regarding the Brewhalla Beer and Music Festival, the Commission passed the following resolution:

PRC22/010

THAT alterative locations to Pioneer Memorial Park be investigated for the Brewhalla Beer and Music Festival.

Discussion

The Brewhalla Beer and Music Festival is scheduled to take place at the Pioneer Park on August 5 and 6, 2022. The Parks and Recreation Commission expressed concerns about the location of this event, noting that the Park is a quiet and sacred place of reflection for residents, and that the tree canopy in the Park is vulnerable and may be negatively affected by a large-scale event. The Commission suggested that Queen's Street Plaza, the Old Firehall Site, or Inlet Field be considered for the event.

In response to questions from the Commission, the Manager of Cultural Services noted that the Crossroads Hospice Society had not yet been contacted to discuss the use of the Park for the event due to a timing issue, but would be contacted shortly. It was also noted that Pioneer Park is an appropriate location considering its proximity to transit, and that other locations suggested by the Commission appear not to be suitable for the event.
