Subject: Neighbourhood Park Promotion Working Group Report

Purpose

To provide Council with information regarding a resolution passed by the Parks and Recreation Commission to present recommendations to activate neighbourhood type park spaces.

Recommended Resolution

Background

At the July 13, 2022 Parks and Recreation Commission (PRC) meeting, the Commission considered a report from the Neighbourhood Park Promotion Working Group (**Attachment 1**) and passed the following resolution:

THAT the Neighbourhood Park Promotion Working Group report be received for information at the earliest opportunity.

Discussion

The Parks and Recreation Commission Neighbourhood Park Promotion Working Group was formed to identify and recommend underutilized neighbourhoods parks for activation and promotion. The Neighbourhood Park Promotion Working Group presented their report, which included their review, findings, recommendations, and appendices (**Attachment 2**). The City's Neighborhood Parks Map is included as **Attachment 3** for background information.

Following presentation of the Neighbourhood Park Promotion Working Group report, the Commission discussed the relationship between population growth and activation of neighbourhood parks, budget and resource requirements to improve infrastructure in certain parks, underserved areas and areas without parks in the city, and the ongoing Parkland Acquisition Strategy project. Details of the discussion can be found in an excerpt from the draft minutes of the July 13, 2022 Parks and Recreation Commission meeting (**Attachment 4**).
