Purpose

To provide Council with information regarding a resolution passed by the Parks and Recreation Commission to provide additional examples from other jurisdictions to support the City's work on the recommendations from the *Paws in Port Moody* report dated July 26, 2021.

Background

At the July 13, 2022 Parks and Recreation Commission meeting, the Commission received a report from the Paws 2.0 Subcommittee (**Attachment 1**). Following a review of the report and recommendations, the Commission passed the following resolution:

THAT the Paws in Port Moody Annex 1: Approaches to Education, Compliance, and Enforcement report be received for information.

Discussion

The Parks and Recreation Commission Paws 2.0 Subcommittee was formed to continue the work of the Dog Management Working Group of 2021 Parks and Recreation Commission. The Subcommittee presented a report that included examples of approaches to education, compliance, and enforcement from other jurisdictions that could support the implementation of the recommendations outlined in the *Paws in Port Moody* report (**Attachment 2**). The Paws in Port Moody Annex 1: Approaches to Education, Compliance, and Enforcement report advised that the City could take immediate actions to improve compliance of on-leash dogs in the community by launching a time-limited public education campaign supported by targeted bylaw education and enforcement in high traffic parks and trails.
