Presentation – Patrick M. Condon

7.1 Presentation: Patrick M. Condon, Professor, UBC School of Architecture and Landscape Architecture

Patrick M. Condon gave a presentation on affordable housing and land values in Metro Vancouver, noting that an increase in density does not necessarily result in an increase in affordable housing stock due to land value escalation. Mr. Condon also noted that inclusive zoning could be considered as a tool to increase affordable housing.

Mr. Condon answered questions from Council about housing supply and demand, rising construction costs, rezoning, development application processing, Development Cost Charges and Community Amenity Contributions, and Official Community Plan (OCP) designations.

7.2 Presentation: Jill Atkey, CEO, BC Non-Profit Housing Association

Jill Atkey gave a presentation on Affordable Housing in Your Community, including information about the Canadian Rental Housing Index, household income spent on rent and utilities, average and median renter household income, national housing strategy, community housing fund, urban development patterns, BC's affordable housing plan, and measures that can be taken by local governments regarding housing.

Ms. Atkey answered questions from Council about the provincial government's housing commitment, development permitting timelines, local government tools to support affordable housing, public use of land and meeting housing needs of the community, streamlining development approval processes, developer and non-profit housing relationships, and acquiring land for housing.

Report: Community Development Department – Policy Planning Division, dated August 24, 2022

Staff gave a presentation on the draft Extreme Weather Resilience Plan, including information about the Plan's purpose, demographic variables, extreme weather scenarios, Plan development timeline, methodology, extreme weather resilience engagement, categories of adaptive measures, and implementation.

Staff answered questions from Council including wildfire smoke and air quality, clean air shelters, air quality in civic facilities, people experiencing homelessness, climate action education and engagement, the correlation between canopy cover and heat, and heat sensitivity in building forms.
