Subject: 2022 General Local Election Results

Purpose

To provide Council with the 2022 General Local Election results.

Recommended Resolution(s)

THAT the report dated November 18, 2022 from the Legislative Services Division regarding 2022 General Local Election Results be received for information.

Background

On November 17, 2022, the Chief Election Officer for the 2022 Port Moody General Local Election submitted the election results report to the City Manager and the Corporate Officer in compliance with section 158(1) of the *Local Government Act*, which stipulates that the Chief Election Officer must submit a report of the election results to the local government within 30 days after the declaration of official election results. This report is provided for Council's information.

Discussion

The 2022 Local General Election was held on Saturday, October 15, 2022. Of the 24,775 electors on the Voters' List, 8,989 electors voted for a voter turnout rate of 36.28%.

Two advance voting opportunities were held in the Wellness Room at the Port Moody Recreation Complex; one on Wednesday, October 5, 2022 and the other on Saturday, October 8, 2022. Mail ballots were issued beginning on September 27, 2022. Legislative Services office hours were extended for two weeks from 8:00am to 8:00pm starting on October 3, 2022 to allow electors to pick up, complete, and drop off their mail ballots at their convenience.

As in 2018, City facilities were used as polling stations in the 2022 General Local Election. For General Voting Day, polling stations were located at 1) Glenayre Community Centre; 2) Heritage Mountain Community Centre; 3) Kyle Centre; and 4) the Recreation Complex. The use of City facilities allowed for set-up at each polling station the day before. It is expected that these locations and other City facilities will continue be the locations of choice for future local government elections.

The determination for the sixth position of Council was made by Judge Lee of the Provincial Court of BC who presided over a partial judicial recount. The final and complete election results following the judicial recount are as follows:
