Subject: Intermunicipal Business Licence for Ride-hailing Bylaws (No. 3400, No. 3401,

At the Regular Council meeting held on April 25, 2023, Council considered a report dated April 3, 2023, from the Community Development Department – Building, Bylaw, and Licensing Division regarding Intermunicipal Business Licence for Ride Hailing Companies and Tri-City Update (**Attachment 1**) and passed the following resolution:

THAT Port Moody continue to participate in the Intermunicipal Business Licence for Ride-hailing as described in the report dated April 3, 2023, from the Community Development Department – Building, Bylaw, and Licensing Division regarding Intermunicipal Business Licence for Ride-hailing Companies;

AND THAT City of Port Moody Intermunicipal Transportation Network Services Business Licence Agreement Bylaw, 2023, No. 3400, City of Port Moody Intermunicipal Transportation Network Services Business Licence Bylaw, 2023, No. 3401, and City of Port Moody Fees Bylaw, 2022, No. 3383 Amendment Bylaw No. 2, 2023, No. 3405 be read a first, second, and third time;

AND THAT the Mayor and Corporate Officer be authorized to execute the Intermunicipal Transportation Network Services Agreement on behalf of the City.

City of Port Moody Intermunicipal Transportation Network Services Business Licence Agreement Bylaw, 2023, No. 3400 (**Attachment 2**)—a bylaw to enter into an agreement among the Participating Municipalities regarding an Intermunicipal Transportation Network Services Business Licence Scheme; City of Port Moody Intermunicipal Transportation Network Services Business Licence Bylaw, 2023, No. 3401 (**Attachment 3**)—a bylaw to enter into an Intermunicipal Transportation Network Services (TNS) Business Licence scheme; and City of Port Moody Fees Bylaw, 2022, No. 3383 Amendment Bylaw No. 2, 2023, No. 3405 (**Attachment 4**)—a bylaw to amend the Fees Bylaw to update the fee for Inter-municipal Business Licences—will be before Council for consideration of adoption at the Regular Council meeting to be held on May 9, 2023.
