#### Details of Request:

Ioco Players Theatre is a volunteer Port Moody-based theatre arts group dedicated to elevating all arts in this community and supporting all arts-related business. We would like to keep all of our productions in Port Moody if they are viable as we believe the community wants this and we believe it strengthens the City's positioning as "The City of The Arts". We are not a registered non-profit and rely on funding our productions through ticket sales, program advertising with community partner support, and concession sales. We promote a diverse range of Arts in Port Moody through advocacy and our social media groups: loco Players Theatre and Port Moody Starts With Arts.

Port Moody has limited performance/rehearsal venues available for local performing arts group. It is our belief that the Inlet Theatre should be a home for volunteer community theatre groups that live, create, rehearse, support local businesses, and who want to create productions exclusively in The City of the Arts.

In 2022, we hosted 3 community productions raising \$6K for the Legion 119 though a dinner theatre performance, and contributed close to \$6,000 in rent only fees to the Inlet Theatre and the Inlet United Church at The Springs.

In 2022, our total production expenses were \$17,694 of which our Summer production at the Inlet Theatre was 61% of our total expenses. The total Inlet Theatre expenses for loco Players (rent, liability insurance, and external rental equipment - piano delivery, tuning, mics) was \$9,655.00. The total 2022 contracted Inlet Theatre fee was \$5666.00 (see page 3). loco Players was provided with a \$3,000 rent waiver from the COPM of which only \$1,939 was eligible towards the waiver. Our final fee payment to the City was \$3477.60 (excluding venue insurance and external equipment rental fees for equipment not available in the Inlet Theatre).

In 2023, our Rent and Extra Fees for the Inlet is \$6810.00 (vs \$5,666 in 2022). We paid the Inlet theatre \$3,477 in 2022 and with a \$3,000 rent reduction would be paying \$3,810 in 2023. This excludes venue insurance, external equipment rentals (see Comparison on Pg 4).

All loco Players performers, crew and volunteers are unpaid. We pay musicians and skilled technicians an honorarium only, or we would have no productions. Ioco Players provides the stage manager, ASM and backstage crew.

I'm an advocate of all arts in Port (Moody and 2023 COPM Civic Arts Recipient) with deep experience building stronger more connected communities. We have 3 full productions planned for 2023 as well as a 6-week Musical Theatre Workshop at PoMoArts. Workshop registration fees pay the pianist (\$600) and space use at PoMoArts. Ioco Player generates no revenue from this event. We applied for a 2023 COPM Community Grant to cover partial costs to host another class and a free concert series but sadly no arts organizations were awarded COPM Community Grants in 2023. Through our events, we have engaged/impacted hundreds and supported and promoted over 30 local business and non-profits. We hope City Council will support this delegation request and be open to future discussions to make the Inlet Theatre more accessible to theatre arts created in Port Moody by residents who live in Port Moody.

#### Additional Information in Support of Request:

**loco Players Theatre** is a volunteer community-based group dedicate to bringing quality theatre productions to Port Moody. Ioco Players was created in Port Moody for the people of Port Moody. In addition to the visibility and \$\$ support we provided to The Legion, Inlet United Church, the COPM Inlet Theatre, and numerous art-related small businesses, we engaged a great number of volunteers and entertained hundreds in and beyond Port Moody. Our Summer production of STAGES: Sondheim & Schwartz at the Inlet Theater also received a nomination from **Applause! Ovation Series** which adjudicates all professional and community theatre production in Greater Vancouver. Ioco Players Theatre was nominated as a "2023 Community Builder Award" by the Tri-Cities Chamber of Commerce. We give back to the community in many way and hope to continue to do this in the future with COPM City Council support.


