#### 1.3 Verbal Report: Councillor Knowles

Councillor Knowles introduced the evening's Art at Council, an acrylic on canvas painting entitled "Thunderbird Teacher" by artist James Groening, or Blue Sky, who is a Burnaby-based Cree artist from Kahkewistahaw Band, Turtle Island.

The Artist thanked Council for the opportunity to speak about their art and noted that their desire to reconnect with their culture and roots is the reason they became an artist. In the beginning, the Artist struggled to find a teacher, but found many fellow students pursuing this journey. The Artist noted that they found inspiration in a work by Norval Morrisseau depicting a man transforming into a thunderbird and explained that elements of "Thunderbird Teacher" parallel the journey of students and represent their connection to a teacher.
