Strata Conversion Policy

The City's Strata Conversion Policy seeks to prioritize the preservation of rental accommodation over privately-owned housing. Given that the approval of the strata conversion does not have any impact on the provision of below-market rental housing units, other than ensuring that the affordability of rents is able to be maintained, staff recommend that the strata conversion be approved.

AND THAT the Mayor and Corporate Officer be authorized to execute the necessary legal documents required in support of this application.
