Subject: Updated Development Approval Procedures, Bylaw No. 3417 – Three Readings

At the City Initiatives and Planning Committee meeting held on July 18, 2023, Council considered a report dated July 11, 2023, from the Community Development Department – Development Planning Division regarding Updated Development Approval Procedures Bylaw (**Attachment 1**) and passed the following resolution:

## CIPC23/032-035

THAT City of Port Moody Development Approval Procedures Bylaw, 2023, No. 3417 be referred to the Regular Council meeting to be held on July 25, 2023, for consideration of first three readings;

AND THAT staff make a concerted effort to post notices regarding public hearings on all of the City's social media channels;

AND THAT the Notification Area stipulated in section 8.2 be amended to one hundred and forty metres (140m);

AND THAT staff report back with wording on options for mailouts on larger developments.

Staff have incorporated these amendments into the draft bylaw. A tracked changes version of the bylaw is included for Council's information as **Attachment 2**.

City of Port Moody Development Approval Procedures Bylaw, 2023, No. 3417 (**Attachment 3**) —a bylaw to establish procedures for processing Land Use and Development Applications—will be before Council for consideration of first, second, and third readings at the Regular Council meeting to be held on July 25, 2023. The recommended resolution is:

THAT City of Port Moody Development Approval Procedures Bylaw, 2023, No. 3417 be read a first, second, and third time as recommended in the memo dated July 25, 2023, from the Legislative Services Division regarding Updated Development Approval Procedures, Bylaw No. 3417 – Three Readings.
