At the Regular Council meeting held on November 14, 2023, Council considered a report from the Fire Chief regarding New Fireworks Regulation Bylaw, No. 3436 and MTIA Amendment Bylaw, No. 3439 – Three Readings (**Attachment 1**) and passed the following resolution:

*RC23/261 (Consent)*

THAT City of Port Moody Fireworks Regulation Bylaw, 2023, No. 3436 and City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 10, 2023, No. 3439 be read a first, second, and third time as recommended in the report dated November 14, 2023, from the Fire Chief regarding New Fireworks Regulation Bylaw, No. 3436 and MTIA Amendment Bylaw, No. 3439 – Three Readings.

City of Port Moody Fireworks Regulation Bylaw, 2023, No. 3436 (**Attachment 2**)—a bylaw to regulate the storage, sales, and use of firecrackers, fireworks, and explosives—and City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 10, 2023, No. 3439 (**Attachment 3**)—a bylaw to amend Municipal Ticket Information Authorization Bylaw, 2020, No. 3218 to align with the new Fireworks Regulation Bylaw—will be before Council for consideration of adoption at the Regular Council meeting of November 28, 2023.
