Subject: GoHere Washroom Program – Report Back from the IDEA Committee

Purpose

To report back to Council on the GoHere Washroom Access Program, which was referred by Council to the Inclusion, Diversity, Equity, and Accessibility (IDEA) Committee for consideration on March 28, 2023.

Background

At the March 28, 2023, Regular Council meeting, a motion was passed regarding the Crohn's and Colitis Canada re GoHere Washroom Access Program:
