Subject: MTIA Bylaw Amendment Bylaw, No. 3440 (Parks and Facilities Rules and

Regulations) – Three Readings

At the Regular Council meeting held on November 23, 2021, Council considered a memo from the Legislative Services Division regarding Parks and Community Facilities Rules and Regulations Bylaw – Adoption (**Attachment 1**) and passed the following resolution:

## RC21/478 (Consent)

THAT City of Port Moody Parks and Community Facilities Rules and Regulations Bylaw, 2021, No. 3321 be now adopted as recommended in the memo dated November 15, 2021, from the Legislative Services Division regarding Parks and Community Facilities Rules and Regulations Bylaw – Adoption.

City of Port Moody Parks and Community Facilities Rules and Regulations Bylaw, 2021, No. 3321—a Bylaw to establish regulations governing the use of Parks and Community Facilities on property owned by the City of Port Moody for Recreation or Community uses—rescinded Bylaw No. 2894. However, corresponding updates to the Municipal Ticket Information Authorization (MTIA) Bylaw were never brought to Council for consideration. Staff have drafted amendments to the City's MTIA Bylaw to align it with Parks and Community Facilities Rules and Regulations Bylaw, 2021, No. 3321.

Draft City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 11, 2024, No. 3440 (**Attachment 2**)—a bylaw to amend the Municipal Ticket Information Authorization Bylaw to align with Parks and Community Facilities Rules and Regulation Bylaw, 2021, No. 3321—will be before Council for consideration of first, second, and third reading at the Regular Council meeting of January 9, 2024.

The recommended resolution is:

THAT City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 11, 2024, No. 3440 be read a first, second, and third time as recommended in the memo dated January 9, 2024, from the Legislative Services Division regarding MTIA Bylaw Amendment Bylaw, No. 3440 (Parks and Facilities Rules and Regulations) – Three Readings.
