



# City of Port Moody

## Bylaw No. 3440

A Bylaw to amend the Municipal Ticket Information Authorization Bylaw to align with Parks and Community Facilities Rules and Regulation Bylaw, 2021, No. 3321.

The Council of the City of Port Moody enacts as follows:

### 1. Citation

- 1.1 This Bylaw may be cited as “City of Port Moody Municipal Ticket Information Authorization Bylaw, 2020, No. 3218, Amendment Bylaw No. 11, 2024, No. 3440”.
