Subject: Amendment to the City of Port Moody Credit Card Merchant Fee Recovery Bylaw

Purpose

To amend the City of Port Moody Credit Card Merchant Fee Recovery Bylaw.

Recommended Resolution(s)

THAT City of Port Moody Credit Card Merchant Fee Recovery Bylaw, 2020, No. 3241, Amendment Bylaw No. 1, 2024, No. 3445 be read a first, second, and third time as recommended in the report dated February 13, 2024, from the Finance and Technology Department – Financial Services Division regarding Amendment to the City of Port Moody Credit Card Merchant Fee Recovery Bylaw.

Background

In April of 2020, as permitted by section 9 of Ministerial Order No. MO 83/2020, the City implemented the acceptance of credit card payments for taxes to further enhance the City's online eCommerce platform. The fee is passed directly to the payee should they elect to use their credit card so that other taxpayers are not subsidizing credit card users.

Discussion

An analysis of the average transaction fee was completed, and a rate of 1.95% was determined. This year staff analyzed the costs incurred with the program and determined that the rate would need to be increased to 2.20% so that the costs of this service are recuperated by the users.

Financial Implications

The increase from 1.95% to 2.20% ensures the recovery fee covers the merchant fees charged by the City's credit card processor.

The credit card merchant recovery fee will be published on the Property Tax Notice, the Tax Newsletter, posted on the City of Port Moody's website, and will be displayed with an agreement checkbox on the property tax payment page (portmoody.ca/eservices).
