THAT City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 91, 2024, No. 3451 (1035 loco Road) (RS1-S) be read a first, second, and third time as recommended in the report dated April 9, 2024, from the Community Development Department – Development Planning Division regarding Rezoning (RS1-S) – 1035 loco Road (Grayden Developments Ltd.);
