Subject: Responsible Consumption of Liquor, Bylaw No. 3456 – Rescind and Give Third

Reading as Amended

At the Regular Council meeting held on May 14, 2024, Council considered a memo from the Community Services Department – Parks Division regarding Responsible Consumption of Liquor in Public Places, Bylaw No. 3456 – Three Readings (**Attachment 1**) and passed the following resolution:

RC24/118 (Consent)

THAT City of Port Moody Responsible Consumption of Liquor in Public Places Bylaw, 2024, No. 3456 be read a first, second, and third time as recommended in the memo dated May 28, 2024, from the Community Services Department – Parks Division regarding Responsible Consumption of Liquor in Public Places, Bylaw No. 3456 – Three Readings.

Staff subsequently identified an error in the draft bylaw. Staff's original intention was to delete section 4.2 before the Bylaw was presented to Council on May 14, 2024. The prescriptive nature of section 4.2 was applicable to the temporary signage that was part of a change management strategy during the pilot phase but will present challenges in effectively implementing permanent aluminum signage at these locations. Removing section 4.2 is intended to allow staff to strategically plan permanent signage that best fits each space with respect to the size of the space, other signage already on-site, and the method of installation.

A tracked changes version of draft City of Port Moody Responsible Consumption of Liquor in Public Places Bylaw, 2024, No. 3456 (**Attachment 2**)—a bylaw to designate certain public places for the responsible consumption of liquor outdoors—is being provided for Council's information at the Regular Council meeting of May 28, 2024.

Staff recommend that third reading of the draft Bylaw be rescinded and that City of Port Moody Responsible Consumption of Liquor in Public Places Bylaw, 2024, No. 3456 (**Attachment 3**) be read a third time as amended. The recommended resolutions are:

THAT third reading of City of Port Moody Responsible Consumption of Liquor in Public Places Bylaw, 2024, No. 3456 be rescinded as recommended in the memo dated May 28, 2024, from the Legislative Services Division regarding Responsible Consumption of Liquor, Bylaw No. 3456 – Rescind and Give Third Reading as Amended;

AND THAT City of Port Moody Responsible Consumption of Liquor in Public Places Bylaw, 2024, No. 3456 be read a third time as amended.
