6. New Business

6.1 Tri-Cities Zero Emission Mobility Plan

Presentation: Senior Sustainability and Environmental Coordinator

Report: WSP

Staff gave a presentation entitled "Tri-Cities Zero Emission Mobility Strategy" and referred to slides contained in the on-table package.

Committee discussion ensued regarding the following topics:

- next steps for implementation and prioritization of tasks based on the Council Strategic Plan and Budget;
- difference between light- and heavy-duty electric vehicles and contribution of microplastics to the environment;
- BC Hydro's ability to match power-grid energy requirements;
- electric vehicle supply chain issues;
- charging station compatibility with different manufactured plug-in designs to ensure universal availability;
- charging infrastructure locations; and
- availability of charging stations on private, commercial, and public land to account for population growth.

The Senior Sustainability and Environmental Coordinator left the meeting at this point and did not return.

6.2 Electric Kick Scooter Pilot Project

Verbal Report: General Manager, Engineering and Operations

Memo: Transportation Engineer

Staff provided a verbal update regarding the Electric Kick Scooter Pilot Project led by the Province of British Columbia, including information about pilot project history, recommendation to extend the pilot project, participating municipalities, and changes to the *Motor Vehicle Act*.

Committee discussion ensued regarding the following topics:

- ability for rules and regulations to be set by the participating municipality;
- methods to prevent users from leave electric kick scooters in dangerous locations;
- plan for charging stations;
- mobility aid device uses on sidewalk or bike lane;
- clarification requested on pilot project length;
- collaboration with participating neighbouring municipalities; and
- opportunities for additional funding available for municipalities opting into the pilot project.

THAT the City's participation in the provincially-led Electric Kick Scooter Pilot Project be endorsed, including for both personal and shared electric kick scooter devices.

- alternative areas that are high-priority excluded from the evaluation.

6.4 Barnet Highway/loco Road/Dewdney Trunk Road Intersection Improvements

Presentation: Senior Engineering Technologist

Staff gave a presentation entitled "Barnet Highway between Dewdney Trunk Road and loco Road" and referred to slides contained in the on-table package.

Committee discussion ensued regarding the following topics:

- clarification on bus modelling and priority lanes;
- cost of the project and completion timelines;
- consideration of building multi-use pathways and improving timelines for pedestrian crosswalks;
- concerns regarding increase of vehicle usage after project completion;
- pros and cons of each proposed model;
- temporary and permanent solutions; and

• collaboration with police department, fire department, and other emergency agencies during the design phase.
