
I live at the end of James road **5.22(1)** Personal Privacy . For the past several years we have endured countless disruptions in our lives with the current construction in our neighborhood.

First of all our street is a dead end with no other access to go in or out. In the past we have had parking issues with the dealerships parking on our street and parents dropping off and picking up their children. All that have to pull u-turns into oncoming traffic to get out. There is limited parking on our street for our neighbors and limited visitors parking in our complex to accommodate those that have visitors that may need to park on the street. Sitka house will already add to t e existing problem once it opens.





We currently have the Sitka project, the elementary school and the apartment building going up next to the police station. We have to endure countless noises including pile driving, drilling, hammering, heavy machinery ( the list is endless) all day long, interruptions to power for Hydro to accommodate these projects and traffic. It is bad enough our street gets blocked off, there are not enough flag people to control the construction traffic. The large trucks required have no turn around to go in and out and have to back into ST Johns with no flaggers to guide them.
