6.1 Phase 2 Public Engagement Results for Master Transportation Plan

Presentation: Transportation Engineer Presentation to be distributed on-table.

The Transportation Engineer gave a presentation entitled "TransPort Moody Climate Action Update - Master Transportation Plan Update" and referred to the slides contained within the on-table package.

Committee discussion ensued regarding the following topics:

- concerns regarding lack of public engagement in project;
- alternative methods to increase public engagement;
- vehicle efficiency at reduced speeds and impact to climate initiatives;
- selective approach for speed reductions based on needs of the area of implementation;
- opportunity to review major arterial routes in the city;
- public transportation's ability to provide storage space for e-scooters and bikes with increased usage;
- potential opportunity to engagement with TransLink;

- opportunities to provide e-bike subsidies;
- concerns regarding funding and timelines to complete Big Moves;
- opportunity to prioritize Big Moves based on community engagement responses; and
- opportunity to revisit material at a future meeting and next steps.
