6.1 Workshop - RCS Strategies

Workshop - Stephen Slawuta

Stephen Slawuta gave a presentation entitled "Recreation Facilities Study" and referred to slides contained within the on-table package.

Members of the group shared their various favourite recreation activities.

6.2 Round Table

Committee discussion ensued regarding the following topics:

"Are there enough recreational opportunities for seniors in Port Moody?"

- insufficiency of seniors recreation opportunities;
- desire for a Seniors' Centre;
- the need for unprogrammed comfortable public spaces for general use;
- the need to improve aesthetics and feel of public spaces;
- the lack of information circulation with the loss of the local newspaper;
- accessibility and transportation challenges to program participation;
- the importance of building community into activities;
- combined social and recreation excursions; and
- the age criteria for the definition of "senior".

"What's changed for recreation in the community over the past 5-10 years?"

(e.g. new or different activity demands, trends, etc.).

- the need for varying levels of physical activity in activities;
- opportunities for volunteerism;
- the effects of the pandemic on trends and needs;
- programs to encourage seniors to remain active and healthy; and

- the need for shade and cooling centres.

"What recreation activity gaps exist?"

- outdoor gathering areas;
- the need for public realm;
- shelter options for year-round use;
- facilities that can be used by multiple age groups; and
- the opportunity to learn from examples from other similar communities.

"What recreation facility and space gaps exist?"

- the previous work performed on Seniors' needs; and
- strong desire for a seniors centre.

"What recreation facility projects should the City prioritize?"

- the need for physical spaces;
- the opportunity to work with developers to include a seniors or recreation space in development;
- the opportunity to lease and use existing space;
- improved experiences and inviting spaces; and
- a heated swimming pool.

"What seniors' facilities in other communities reflect "best practices" that we can learn from?"

- Maillardville Community Centre in Coquitlam;
- integrated spaces being dedicated to different demographics throughout the day; and
- Saint Albert, Alberta.

"How can recreation facility investment get more seniors, more active?"

- centralization and accessibility of facilities; and
- warming sheds.

Final Thoughts:

- the complexity of determining what seniors want, even for themselves;
- the importance of multi-function spaces;
- consideration of concept of multi-generational spaces that are shared through dedicated timeslots or family involvement;

- challenges in trying to get subject matter experts for activities and volunteers to assist programs;
- the importance of providing social spaces;
- the importance of healthy, active seniors;
- the benefits of multi-generational social activities;
- the need for support from the City to assist volunteers to easily form extra-curricular activity groups;
- the need to include diverse voices in the conversation;
- cost-free inviting spaces; and
- timelines.
