## Bylaw No. 3543

A Bylaw to amend City of Port Moody Fees Bylaw, 2025, No. 3524 to update Highway Use Permit fees and Pay Parking Fees.

The Council of the City of Port Moody enacts as follows:

### 1. Citation

- 1.1 This Bylaw may be cited as “City of Port Moody Fees Bylaw, 2025, No. 3524, Amendment Bylaw No. 2, 2026, No. 3543”.

### 2. Amendments

- 2.1 City of Port Moody Fees Bylaw, 2025, No. 3524 is amended by replacing the following table in Schedule A:
