4. New Business

Delegation – Port Moody Active Transportation Safety Committee

4.1 Lesley Evans Ogden gave a presentation on a Plea for Safe, Equitable Kid-Friendly Active Transportation Structure and noted that she is a member of the Port Moody Active Transportation Safety Committee that is working towards solving safety issues regarding foot and cycle transportation, especially around schools.

Ms. Evans Ogden noted that the Committee's biggest concerns are speeding and the connectivity of active transportation routes with other municipalities.

The General Manager of Operations and Engineering noted that traffic calming measures such as flashing yellow lights, street narrowing, and curb extensions have been installed in the area.

The Chair noted that a resolution requesting that municipalities be granted the authority to create 30km/hr zones within their jurisdiction will be submitted at the UBCM Conference next week.

Kathleen Nadalin noted that ICBC offers road safety programs that offer road safety education for students and can help identify areas for safety improvements,

Ms. Evans Ogden left the meeting at this point and did not return.

Suter Brook Public Space Improvements

3.2 The Manager of Infrastructure Engineering Services gave a presentation on Suter Brook Village Traffic and Public Space and requested the Committee's feedback on safety and traffic concerns.

Staff and Committee members discussed the many options that could increase safety for all modes of transportation and the following ideas were noted:

- better and more signage promoting free parking in the underground parkade;
- implement paid parking with a higher rate for above-ground spots;
- relocate the parkade entrance to the outside of the Village;
- change Suter Brook Way to a pedestrian and loading area only between Morrissey Road and Brew Street;
- change the parking spots in front of Romer's to loading zone only until 8pm;
- paint bike lanes green;
- change to a one-directional road; and
- create a dedicated commercial loading zone.

<u>Action</u>: The Manager of Infrastructure Engineering Services to incorporate the Committee's feedback into a new report and present at October's meeting with the purpose of creating a recommendation to forward to Council.
