### Background

At the July 2019 meeting of the Parks and Recreation Commission, the Parkland Acquisition Strategy Working Group was formed to support the development of the Request for Proposal by providing recommendations to staff on objectives, framework, and key deliverables.

### Discussion

The Parks and Recreation Commission Parkland Acquisition Strategy Working Group provided updates and offered opportunities for the Commission members to provide feedback on the report at the meetings of September and October 2019. At the November 2019 Parks and Recreation Commission meeting, Commission members reviewed the final report and approved its submission to Council and the following resolution was passed:

THAT Council consider the Guidance Report to Inform the Development of Port Moody's Parkland Acquisition for use by City staff so that the Terms of Reference, that will inform the City's hiring of a consultant in 2020 to develop a Parkland Acquisition Strategy, is in alignment with this report;

AND THAT Council consider that the draft Terms of Reference be reviewed for input by the Parks and Recreation Commission prior to public release;

AND THAT Council consider providing this report to the consultant as a guiding document and that the consultant be directed to consider it as part of their work, bringing forward current trends and best practices.
