Purpose

To provide Council with information regarding a resolution passed by the Parks and Recreation Commission to approve the Rocky Point Park Visioning Exercise.

Background

The 2019 Parks and Recreation Commission Work Plan contains the work item Rocky Point Park Visioning Exercise that would provide Council with preliminary input into issues and needs that are emerging in Rocky Point Park as its popularity grows, as well as ideation around possible opportunities and solutions to address these issues and needs.

At the October 9 and November 13, 2019 Parks and Recreation Commission meetings, the Commission discussed the current state of the park and offered ideas for meeting the user demands over the next two decades. The following resolution was passed at the November 13, 2019 Parks and Recreation Commission meeting:
