## Purpose

To provide a report on the activities of the 2019 Seniors Focus Committee.

## Recommended Resolutions

#### **Committee Mandate**

The purpose of the Seniors Focus Committee is to provide recommendations and advice in the following areas:

- the recommendations provided in the Age Friendly Community Planning Project report;
- short-, medium-, and long-term goals to address seniors' issues within municipal jurisdiction;
- opportunities for strengthening the City's existing recreation programs and services for seniors;
- current and future trends that may influence the delivery of recreation services and facilities for seniors;
- opportunities for corporate alliances;
- seniors' issues, strategies, and initiatives within municipal jurisdiction; and
- any other matters referred by Council.

# Meetings and Attendance

The Seniors Focus Committee met monthly between February and December 2019, with the exception of August 2019 due to summer break.

# Key Activities and Work Plan

The 2019 Seniors Focus Committee Work Plan was approved by Council on June 25, 2019. The following are the key activities that were undertaken in 2019 by the Seniors Focus Committee:

#### Trail Accessibility Study

On October 18, 2019, members of the Seniors Focus Committee, City staff, and members of the Newport Walking Club undertook a trail audit of the Shoreline Trail. Three groups of participants walked portions of the trail and provided an evaluation of the adequacy of rest stops, accessibility for walkers and those in mobility devices, uneven surfaces, pooling water or slippery sections, as well as perceptions of safety and visibility. Positive aspects of recently upgraded portions of the trail were also discussed.

#### Age-Friendly Plan

With funding from UBCM, the Seniors Focus Committee initiated the development of an Age-Friendly Plan for Port Moody and established a Steering Committee to provide direction for the how the Plan would be developed. Seniors Focus Committee members who participated on the Age Friendly Steering Committee included John Crowther, Yvonne Harris, Amy Lubik, Liam McLellan, Connie Meisner, Paulette Gurski, Yolanda Broderick, community member Bev Bakka, as well as representatives from Fraser Health Authority, Tara Abraham and Richelle Foulkes. The Plan included community feedback through focus groups, one-to-one interviews, an online and paper survey, and a Stakeholders' Walkability/Wheelability Audit in Neighbourhood (SWAN) activity; the data were collected and grouped according to the Public Health Agency of Canada's Age-friendly evaluation indicators. According to participants in the community consultation, there are currently many Age-friendly features in Port Moody. Community members and service providers also identified key barriers that could be reduced

with future Age-friendly initiatives. Recommendations for improving Port Moody's age-friendliness are outlined with timelines, actions, partners, and linkages.

#### Seniors Centre Field Trip Discussion

The November 15, 2019 tour included Glen Pine Centre (Coquitlam), Guildford Recreation Centre (Surrey), South Surrey Centre (Surrey), and the White Rock All Abilities Playground. Participants included: Malcolm Harkness, John Crowther, Tonny Scholten, Zoë Royer, and Ruth Cox. Participants were asked to provide their feedback in terms of an overall assessment of the facility, which aspects of the building were most interesting, which aspect appealed to participants, what they liked least about the facility, and an listing of available programs.

#### Council and Seniors Focus Committee Joint Workshop

On April 30, 2019 a workshop was held in the Brovold Room between the Seniors Focus Committee and members of Council. Tonny Scholten provided a presentation on key aspects needed in a seniors centre in Port Moody. Ken Kuhn provided an overview of what makes an age-friendly or dementia-friendly community.

# Suggested Focus Areas for Next Year

The following focus areas are suggested for the 2020 Seniors Focus Committee Work Plan:

- engaging the Alzheimer's Society to provide dementia friendly training for front line staff;
   this could include Stroke BC to provide education/awareness of stroke survivors;
- reviewing accessible bus stops;
- developing an age-friendly business program, including a "blue umbrella" program, a business-supported wayfinding for those with dementia; and
- webpage of seniors resources.
