Call to Order Mayor Vagramov called the meeting to order at 5:02pm. RC20/045 Moved, seconded, and CARRIED THAT item 4.4 be addressed immediately.

Prioritizing Pedestrian 4.4 Crossings Report: Mayor Rob Vagramov, dated January 21, 2020

RC20/046

Moved, seconded, and CARRIED

THAT staff update the Master Transportation Plan Implementation Plan to accelerate the high priority pedestrian-activated signal improvements for the intersections of Elgin at Clarke, Queens at St. Johns, and Clarke at Seaview, with construction of the Clarke Street at Elgin Street pedestrian signal targeted for completion in 2020;

AND THAT staff be directed to report back with an updated Master Transportation Plan Implementation Plan, including cost estimates and postponed projects;

AND THAT staff be directed to add a section to the outstanding business list that reports back to Council every quarter to include motions of Council that have had no action on them from the previous quarter as recommended in the report dated January 21, 2020 from Mayor Rob Vagramov regarding Prioritizing Pedestrian Crossings.

The agenda order was resumed at this point.

2. General Matters

<u>RC20/047</u> Moved, seconded, and CARRIED **THAT a Public Input period be added to the agenda.**

Ilse Leis (Port Moody) expressed concerns about the proposal put forth by the Moody Centre TOD Area Master Planning Group at the Committee of the Whole meeting held on January 21, 2020 and submitted a letter outlining those concerns.

Richard Biedka (Port Moody) expressed support for the Moody Centre TOD Area Master Planning Group proposal to move forward for public consultation and review, and requested that Council allow the process to proceed.

John Wildman (Surrey) noted that, as a property owner in Moody Centre, he has participated in Moody Centre TOD Area Master Planning Group meetings, and that such a development would be beneficial for Port Moody. Mr. Wildman expressed concerns that the Mayor's motion would set back development in the city for a long time. Rob Blackwell (Port Moody) noted that the Moody Centre TOD Area Master Planning Group is a group comprising a broad range of property owners and developers; the Group was tasked with conducting the master planning exercise, and has worked hard to put together a framework based on the City's Official Community Plan. Mr. Blackwell noted that the current proposal is a draft, and asked Council to allow the process to proceed.

Stirling Ward (Port Moody) thanked Council for adding public input to the agenda. Mr. Ward noted that the development of Moody Centre would be an opportunity for many amenities to be built in Port Moody, and encouraged more public participation in the process. Mr. Ward asked Council to work collaboratively as a group and with the Moody Centre TOD Area Master Planning Group and to encourage public input in the process.

Gaëtan Royer (Port Moody) thanked Council for approving acceleration of crosswalk construction at Clarke Street and Elgin Street. Mr. Royer expressed support for the Moody Centre TOD Area Master Planning Group presentation, and noted that public consultation would be an important part of the process.
