> The Manager of Parks gave a presentation on Old Firehall No. 1 Site: Committee Input on Potential Interim Uses and requested Committee members' input on ideas for interim uses. The Chair led a brain-storming exercise and the following ideas were noted:

- bocce ball courts;
- putting green;
- small gazebo in centre of area;
- walking track on perimeter;
- park space similar to Pioneer Park;
- Risky Play pop-up park;
- Concrete picnic tables with holes for umbrellas;
- outdoor beach area;
- horseshoe pits, hopscotch, concrete ping pong tables, squareball, pickleball, and basketball courts;
- outdoor movies;
- farmers markets and art shows in the summer;
- outdoor fitness stations for all ages and abilities;
- coffee carts and food trucks;
- seating and benches;
- small petting zoo;
- firehall themed area creating an ode to the old firehall with education on previous use of the land;
- complimentary ideas to create a gathering place for all to enjoy;
- Stream of Dreams for fencing and hosting a pop-up event to paint the fish;
- sponsored pop-up events with corporate partners;
- outdoor classroom or art space for youth;
