- separating "Business" and "Citizen" categories for the proposed Climate Action Committee award;
- education on food systems, food waste, composting, plastics reduction and other solutions, including demonstration and talks; and promoting support of Farmer's Markets;
- ongoing community engagement and interaction opportunities at events (such as Car-Free Day, RibFest, and Golden Spike Days) to encourage regular actions on climate;
- including a standing item on the Committee agenda for climate action-related events and activities;
- providing input on the Sustainability Report Card update;
- inviting speakers on the following topics, subject to availability: political and citizen climate action; passive energy building; thermal comfort in buildings and current climate projections and future weather files; applying a climate lens to the Official Community Plan;

## Film Subcommittee Update

- 4.4 The 2019 Film Subcommittee provided an update on their work, noting the following:
  - a film showing around Earth Day could be considered;
  - a film "festival" series with more regular showings could also be considered, with a potential to partner with the Port Moody Film Society;
  - one proposed film is "Women Bending the Curve", followed by a discussion panels;

- whether there would be an admission cost to the film showings could depend in whether a fee waiver for the Inlet Theatre, including for insurance fees, could be secured: and
- Sunday afternoons could be considered for film showings.

## Climate Action Plan Update

4.5 Sustainability and Energy Coordinator

Staff gave a presentation on the Climate Action Plan, reviewing the development timeline, project scoping, community engagement process, and risk and vulnerabilities assessment process, noting the following:

- Port Moody is the first community to use a low-carbon resiliency lens to development the Plan from start to finish, which considers mitigation and adaptation as one process;
- the Plan was developed through Simon Fraser University (SFU)'s Integrated Climate Action for British Columbia Communities Initiative, with SFU providing in-kind support during development;
- the Plan targets 45% carbon reductions by 2030, and carbon neutrality by 2050;
- Council's Climate Emergency Declaration in June
   2019 resolved to incorporate new actions into the Plan;
- a lengthy process was undertaken to narrow down and prioritize the proposed actions, and senior staff are currently focused on implementation analysis and feasibility review.

#### CAC20/005

Moved, seconded, and CARRIED **THAT the meeting be extended by 10 minutes.** 

Staff continued the presentation, noting the following:

- the Plan is at 80% completion with a target of May 2020 for presentation to Council;
- if Council approves the draft Plan, the next steps would include conducting financial analysis and seeking funding source for the recommended climate actions; and
- the Committee has a role in helping shape how the targets can be met.
