### Understanding Stroke Victims

4.1 Presentation: Jill Jukes, Regional Manager, Stroke Recovery Association of BC and March of Dimes

Jill Jukes gave a presentation on the Stroke Recovery Association of BC (SRABC) and the following was noted:

- the Heart and Stroke Foundation of BC provides funding for research and prevention and the SRABC delivers after-stroke programs and services for stroke survivors and their care partners;
- a stroke is a brain bleed or blockage which can impact the survivor cognitively and/or physically;
- the community-based recovery programs are developed to be person-centred, following the Canadian Stroke Best Practices Recommendations, and are guided by the belief that every stroke survivor has the potential to get better:
- the financial hardships faced by stroke survivors can be a barrier to accessing programs as they are now faced with higher expenses and lower income prior to having the stroke; making programs and services more accessible in communities is essential; and
- the stroke survivors often self-manage the recovery process once they have returned home; to achieve their goals the community requires more services to provide support, resources, information, and networks.

Ms. Jukes noted the following in response to Committee members questions regarding the presentation:

- there is no program in Port Moody; however, work with Heart and Stroke and Provincial Health Services Authority is ongoing to address the gaps and determine how community programs can compliment one another;
- the SRABC was initially formed by "community navigators" who advocated to have the programs offered in the communities they live;
- the current programs in Coquitlam, Abbotsford, and Kelowna were noted as reference for model partnerships with City staff and SRABC; there are many ways to offer programs in the community on a small budget;
- the Fitness and Mobility Exercise Program by Dr. Janice Eng could be incorporated into recreation programming;
- the Tetra Society of North America is a volunteer group that design and build assistive custom-made devices; and

## Presentations for Seniors in the Tri-Cities

- provide an extended advertising time prior to the scheduled event;
- provide more information on the dedicated City of Port Moody Seniors webpage; and
- advertise in locations such as the TV in the Galleria, the Port Moody Museum Kiosk, and Seniors Housing information boards.

The Social Planner noted that the Age-Friendly Plan contains material on Communicating Activities and Materials for Seniors and the City will be working with the Communications Department to improve this area.
